PLAYER RESPONSIBILITY AGREEMENT

Whilst it is the team manager's role to manage the team, each individual player is responsible for his or her own care. The following list should not be seen as exclusive and may be amended from time to time at the duly appointed manager's discretion. Players are responsible for:

- Hygiene and personal care
- Professionalism both on and off-court
- The responsibilities of representing their team/state/country including:
 - always be on their best behaviour
 - 100% commitment
 - watching and supporting team mates
 - being available for other team members for practice partners, support, and encouragement
- First-hand match analysis - finding out about opponents in consultation with coach
- Gaining permission from the coach - keeping in touch with coach/manager
- Leave nothing up to chance - do everything to produce the best performance, including:
 - getting enough sleep
 - game preparation and plan
 - drinking enough fluids
 - eating correctly
- Checking match times for the next day - entry and withdrawal of opponents
- Make sure equipment is in good working order (racquet re-stringing etc)
- Self-sufficiency:
 - doubles partner
 - organising practice partners
 - towels and water
 - signing-in to tournaments
 - showering after practice and
 - meals and eating at right times
 - booking practice courts
 - matches
 - completing diaries
 - scouting opponents
 - sleep
- Empathy for coach/manager and other members of the team
- Players must not partake in the consumption of alcohol or any prohibited drugs. Any player caught in breach of this requirement will be immediately sent home at the family's expense. Any player caught engaging with, or in the presence of, others who are consuming alcohol/prohibited drugs, risks similar discipline at the discretion of the team manager(s).

Managing a team is an incredibly demanding role and the co-operation and support of team members is required at all times. Players should abide by team rules and regulations at all times during the tour, to ensure that the tour is as enjoyable as possible. This will help to maximise the experience and benefit gained by both players and managers.
