STV WINDEWARD BOUND SHIP'S ARTICLES - SAIL TRAINEES

A contract between HARVEY YOUNGS_ (the Applicant)
And CAPTAIN SARAH PARRY, MASTER
For the voyage from DEVONPORT 6/10/23
To HOBART 15/10/23

To: THE WINDEWARD BOUND TRUST (Hereinafter referred to as "The Trust"). In consideration of your accepting at your discretion my application to crew on the ship STV WINDEWARD BOUND on a voyage as a SAIL TRAINEE.

1. I, the Applicant, shall contract with The Trust to serve in the business of the ship as a SAIL TRAINEE for the duration of the voyage.
2. As a SAIL TRAINEE, I shall during the voyage:
 - a. Obey all lawful commands of the master of the ship, her officers and deputies, and abide by the ship's rules (Standing Orders) as laid down.
 - b. Undertake to carry out, to the best of my abilities, such duties as may be allocated to me.
 - c. Do nothing to jeopardise the safety of the ship and its officers, crew and equipment, nor do anything to negatively affect the marine environment.
 - d. Not bring aboard the Ship any alcohol, tobacco, prohibited drugs, or any prescription drugs not disclosed in the health questionnaire. Possession or use of the above will result in my removal from the ship at the first port of call. The ship will be diverted to such port if necessary.
 - e. Use my best efforts to co-operate with the officers and crew towards a happy spirit aboard ship and maintain an appropriate state of personal hygiene.
 - f. Co-operate fully with all safety induction training carried out as part of the voyage and observe a responsible Duty of Care towards the safety of my shipmates, the ship, and myself.
3. I acknowledge that, at times, the voyages may be hazardous and that, nevertheless, I assume all risks of, and associated with, the voyages and that I am satisfied that adequate Protection and Indemnity insurance is in place.
4. I release and shall indemnify The Trust and the Ship's Owners and their respective employees, agents, independent contractors and directors from, and against, liability to or relating to the applicant in respect of any such matter or action in contravention to any undertakings given above.
5. I acknowledge that any failure to adhere to the Conditions of this contract may cause the cancellation of this contract and my removal from the ship. I acknowledge that any such decision will be at the discretion of the Master, or in her absence, The Trust's representative.

6. Should the circumstances in clause 5 be initiated, I understand that any travel costs resulting will be payable by me.
7. I understand that In the event of The Trust being unable to continue the contract for any reason (E.G. the cessation of the planned voyage(s) due to any circumstances) not related to the above clauses, and the voyage is terminated, then this contract ceases to be effective.
8. I accept that The Trust has full copyright ownership of all images, (which includes still, video, and film images of any kind), sounds, stories, internet and computer records, and all print media of any kind taken while in the service of the ship and/or that feature or refer to in any way STV Windeward Bound, The Trust, or their respective Officers, crew, employees, agents, and/or directors. I accept that I may not use any of these for commercial gain, financial and otherwise, without the written permission of the Trust, which may be negotiated from time to time. There are no limitations to any non-commercial or private use of the above.
9. I accept that The Trust has a right to copies of all photos/video/sound recordings or images produced by any means and may use them free of any copyright on the Trust's website, or in any other promotional material generated by or for the Trust, free of any fees or payments.
10. I acknowledge that as a SAIL TRAINEE, I will, from time to time, be filmed, video' d or photographed in the course of my time on board and I hereby consent to the use of those records by The Trust, or The Trust's contracted media representatives, for whatever purpose is required. I understand I will receive no payment for that use. I understand that I can request not to be photographed or otherwise recorded. Such request must be made direct to the Master and will be honored accordingly.
11. No SAIL TRAINEES (except as requested by a Ship's Officer) are to enter the sleeping space of the opposite gender. SAIL TRAINEES are only permitted to enter the sleeping space allocated to them by Ship's Officers.
12. No SAIL TRAINEE will swap bunks or cabins with any other person. It is vital for your safety in an emergency that we know precisely where to look for you, which is the bunk that has been designated to you. Valuable time, and the lives of yourself or others may be at risk.
13. All SAIL TRAINEES must always wear suitable clothing . No singlets, inappropriate, suggestive or revealing clothing is to be brought on the voyage. All t-shirts must have sleeves and cover the midriff. No clothing with offensive language is permitted. Sleeved tops must be worn at mealtimes.
14. Skirts and thong style sandals, walking boots, Blundstone type boots and Doc Martin type boots are not permitted on board at any time. Soft soled shoes, sneakers (trainers,) Dunlop "Vollies", and sports sandals (and rubber seaboots for wet weather) are the only approved footwear. Please note - Bare feet are acceptable only on deck; trainees must not climb aloft in bare feet. Socks must never be worn without shoes.

15. Mobile phones, iPads, and iPods are not permitted on the voyage. If they cannot, for whatever reason, be left at home, they are to be handed to the Ship's Officers who will tag them and keep them in the Ship's safe for the duration of the voyage. They will be handed back to you before dis-embarkation at the end of the voyage. In the event there is a genuine reason to retain your device, representation must be made to the Master and the Voyage Co-Ordinator. There is no guarantee permission will be given. Electronic reading devices are permitted for off duty use.

16. This contract is governed by the laws of Tasmania and Australia.

17. In the event of an accident or serious illness, I hereby give permission to the Commanding Officer of STV Windeward Bound to seek medical attention on my behalf.
